What is the overall deductible?	\$0	See the Common Medical Events chart below for your costs for services this plan covers.
Are there services covered before you meet your deductible?	Not Applicable.	This plan does not have a deductible .
Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan?	<p>For covered medical services obtained at Kaiser: \$1,500/person; \$3,000/family.</p> <p>The Prescription Drug and Ancillary Benefits OOP limit (applicable to prescription drug copays, expenses for injectable drugs not provided by Kaiser, and chiropractic/acupuncture not provided by Kaiser): \$6,650/person; \$13,300/family).</p>	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit?	<p>For medical services obtained from Kaiser: services indicated in the chart starting on page 2, health care not covered by Kaiser.</p> <p>The Prescription Drug and Ancillary Benefits OOP limit: expenses for non-formulary drugs without a PBM-approved medical exception and services and supplies from a Kaiser provider.</p> <p>Premiums, balance billing charges, and health care this plan doesn't cover are not included in either out-of-pocket limit.</p>	Even though you pay these expenses, they don't count toward the out-of-pocket limit .

Will you pay less if you use a network provider ?	Yes. See www.kp.org or call 1-800-278-3296 (TTY: 711) for a list of network providers .	This plan uses a provider network . You will pay less if you use a provider in the plan's network . You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Be aware your network provider might use an out-of-network provider for some services (such as lab work). Check with your provider before you get services.
Do you need a referral to see a specialist ?	Yes, but you may self-refer to certain specialists .	This plan will pay some or all of the costs to see a specialist for covered services but only if you have a referral before you see the specialist .
